In the event that this is not possible, YOU are still financially responsible for any vet bills & costs of disposing of body, PLUS a replacement cost of market value for cattle - \$800 or more

**** There is NO SHADE – please bring your own shade tents, tarps etc.**

****Please be considerate of the grounds you are using. It is a privilege to come & work your dog(s).**

****Run dogs at your own risk.**

****The ground is not perfectly flat. Be careful when you & your dog are working.**

****All dogs are to be on leash, unless working**

****Keep dogs away from working area until it is your turn...unless told otherwise.**

****DOGS are NOT allowed to create any disturbances or interact with any dog or stock.**

****PLEASE keep your dog quiet.**

**** PICK UP dog poop EVERYWHERE in the common area –**

****NO Children allowed in the holding pen area where the cattle are kept**

DIRECTIONS TO TRIAL SITE: 794 Brant Farnham Road (Rte 249) Irving, NY GPS will frequently take you past the arena – Watch for signs

NYS Thruway Exit 57A (Eden/Angola) Right off the ramp onto Eden-Evans Center Rd. 1.3 miles make a Left / West onto Rt 20. In 6 miles make a right onto Rt 249. About .7 miles on the right will be the driveway for the Double S Arena.
