# 2017 Sheepdog Trial Guidelines and Information

- 1. Entries Due:** Please postmark between October 2 – 6, 2017
  - Mail to: KBSDA, 3701 County Road 114, Tulelake, CA 961334
  - Entries will be treated with equal consideration.
  - Handlers will be notified of entry receipt via bulk email on October 16
- 2. Entry Checks:**
  - No refunds after October 26, 2017
  - Make checks payable to KBSDA
  - Confirmed entries and if necessary wait list will be published on October 23
- 3. Trial Format:**
  - 3 One-Day trials, November 10, 11 and 12
  - Each dog will run 2 of the three days with no preference.
- 4. Course Info:** Course may include 400+ yard outrun, 450 yard drive, shed, pen and single. Note: The course may be adjusted as necessary for weather or time constraints. Failure to handle stock properly in a quiet and workmanlike manner may result in disqualification.
- 5. Running Orders:** Running orders will be emailed October 28<sup>th</sup> and published at [www.bcollies.com](http://www.bcollies.com)
- 6. Awards:** Cash awards to 3<sup>rd</sup> place each trial.
- 7. Handler's Meeting:** To be announced
- 8. Leash Law:** There will be strict enforcement of leash law by the UC HREC. All dogs must be on leash at all times outside the trial area, designated handler parking or dog "potty" areas. Dog leash dragging freely, not tied to or held by stationary object are considered off leash. Handlers who allow dogs off leash will risk disqualification from the competition.
- 9. Lodging:** No camping on site. Cloverdale and Ukiah are about equal distance to the trial.
