**Open Class will run Sat and Sun. Nursery Class and Pro-Novice Class will run twice on Monday.**

**Nursery Class run 1<sup>st</sup>, PN class 2<sup>nd</sup>, Nursery Class 3<sup>rd</sup>, PN Class 4<sup>th</sup>.**

**ENTRIES WILL BE LIMITED BASED ON POSTMARK**

**ENTRIES OPEN October 10, 2017 and CLOSE Oct. 20, 2017 NO refunds after Oct. 20, 2017.**

**Range Sheep will be used for all classes at this trial**

**OPEN:** \$65 per day. Awards to 3<sup>rd</sup>, cash prizes and ribbons to 5<sup>th</sup>. Les Bruhn Memorial Trophy to high combined Open score. **Course:** Outrun, lift, fetch, drive through two sets of panels, shed, pen, single.

**NURSERY:** \$43 per. Run.. Award for 1<sup>st</sup>, ribbons to 3<sup>rd</sup>. **Course:** Outrun, lift, fetch, drive through two sets of panels, pen.

**PRO - NOVICE:** \$40 per run. Awards to third, cash prizes and ribbons to 5<sup>th</sup>. **Course:** Outrun, lift, fetch, drive through two sets of panels, pen. Limit of two dogs per handler per class. 3<sup>rd</sup>. dog separate check if space permits.

A handler may only receive two money awards per class.
