

DIRECTIONS TO TINGLEY TRIAL FIELD, TINGLEY, IA:

Tingley trial field has no physical address, but it is on the corner of 4th St. and Jefferson St., kitty-corner to the Tingley United Methodist Church 303 Jefferson St, Tingley, IA 50863.

FROM THE NORTH:

I-35 South to Osceola, IA. Take Exit 33 onto the Hwy. 34 West for 21.2 miles. Hwy 169 will meet up with Hwy 34 W. Turn left on Hwy 169 S/N Douglas St. Go through the town on Afton and follow 169 S for 12.9 miles. Turn left on J20 towards Tingley. The pavement/J20 will turn to the right, do not follow the turn, instead go straight on the gravel. The arena is immediately to the right, this is where campers can camp/park as well. For the trial field go ½ mile further to the corner of 4th and Jefferson. The trial field is kitty-corner to the Tingley United Methodist church. The field is on the North East corner of the intersection. Parking is on the southeast corner of the intersection. We will have signs to trial field.

FROM THE SOUTH:

I-35 North to the Iowa Border. Take Exit 114/ Hwy.69 North (just before crossing into Iowa) to Lamoni, IA. Follow HWY 69 to Lamoni. In Lamoni, turn left/West on Main Street and follow County HWY J55 west for 8.5 miles, Turn right on to County RD P64 and follow for 16.4 miles. Turn Left on County Rd J20 and follow this for about 3.5 miles. J20 will curve to the Left/South at the edge of Tingley, instead of taking the curve, go straight onto 4th St. you will cross 250th Street, Madison St and the trial field is on the NE corner of Jefferson and 4th Street. Parking is to the south. We will have signs to trial field.

CAMPING:

Limited camping is available two blocks from the trial field at the novice arena. No hook-ups available. **Please let us know if you plan to camp.**
