

2018 CASCADE FARM SDT MAY TRIAL INFORMATION

TRIAL FIELD: All classes will run on our 40 acre HAY FIELD. Please be careful where you drive. There are no permanent fences on the field. The road down into our farm crosses a NARROW but heavy duty bridge. Stay wide to the right at the bottom of the hill if you are long or towing a trailer. **Follow signs for parking and camping.** If the weather is wet and you do not have a 4x4 consider parking at the entrance to the field and walking. We can park 2-3 big rigs at the top of the hill by our round bales. Please let us know if you will need a spot there.

DIRECTIONS: First timers and **CAMPERS/RV'S** **USE Cascade Farm directions on the NEBCA website.** www.nebca.net.trialschedule.html Cascade Farm, Not all GPS will direct you to our farm.

60 dogs maximum, if numbers go over allotted amount we will use a DRAW to determine entries.

HANDLER'S MEETING 7:00 AM: Weekend class order will be Pro-Novice, Ranch, and Open. Pro-Novice dogs will do a Canadian drive (drive with a short cross drive). Nursery dogs will run with Ranch entries, Saturday only if there are enough entries.

SHEEP: We will be using Katahdin Hair Sheep, dog and pressure sensitive.

RULES: Trial will follow NEBCA and USBCHA guidelines. **Dogs must be leashed, hooked, or crated during the trial.** Please clean up after your dogs if they poop in the tent and camping areas. **Please take your trash home with you.** You may let your dog off-leash with supervision before or after the trial. No puppies will be displayed for sale. Unsportsmanlike conduct will not be tolerated.

Ribbons and Prizes: Ribbons will be awarded in all classes.

FOOD: There will be morning coffee and muffins or bread. Lunch is on your own. The Bath Brick Store or the Lisbon Riverside Market make sandwiches, etc. There is no planned pot luck, you may plan your own or there are several eateries in the area.

Directions to Cascade Farm, Bath, NH

THE BATH COVERED BRIDGE IS LIMITED TO AUTOS ONLY. CAMPERS AND RV'S PLEASE USE THE FOLLOWING DIRECTIONS:

From I-91 – Take Exit 17 off I-91, Wells River and follow US ROUTE 302 EAST through town of Wells River, VT to Woodsville, NH. In Woodsville turn LEFT onto NH ROUTE 135 NORTH, cross over Ammonoosuc River .3 miles and take RIGHT onto ABBOTT AVENUE following river .8 miles. Turn LEFT onto MOUNT GARDNER ROAD go 2.3 miles. At T turn RIGHT onto WEST BATH ROAD go 2.1 miles. The road is winding with several sharp curves. Turn LEFT onto PETTYBORO ROAD. Cascade Farm is 1.6 miles on your RIGHT. Follow signs to trial field.

From I-93 – Take exit 42 off I-93, Littleton follow US ROUTE 302 WEST. In center of Lisbon by fancy light post turn RIGHT onto SCHOOL STREET crossing Ammonoosuc River. Take SECOND LEFT onto WEST STREET, follow road along river (West Street becomes Bath Road then Dodge Road) 3.1 miles. At T turn LEFT onto PETTYBORO ROAD. Cascade Farm is at the top of the rise on your LEFT, .6 miles. Follow signs to trial field.
