The Massachusetts Sheep and Woolcraft Fair is happy to host two 1-day Novice and Open Trials over a three day period, May 25 and 27, sanctioned by the Northeast Border Collie Association and the USBCHA. The trial is tentatively scheduled start at 10am and to run two classes each of Novice/Novice and Pronovice on May 25. Ranch - USBCHA Nursery and Open will run once each day May 26 and 27.

Handlers are limited to two dogs per open or novice class. No dogs will be able to run in both ranch and open. Please send a separate check for USBCHA Nursery.

The USBCHA Nursery Class will run if minimum of 5 eligible dogs are entered. Please note the Ranch and USBCHA Nursery class will be run together. If you want to enter both ranch and Nursery, you will get one run or you can enter PN and Nursery with the PN runs on Friday and the Nursery runs on Saturday and Sunday. Fees for a dog entered in both ranch and Nursery will be \$45. Otherwise Ranch will be \$35 and Nursery will be \$33.

Classes will be run according to the current NEBCA Novice Guidelines.

All handlers are invited, at the end of the trial on Saturday, to the NEBCA meeting followed by a Pot Luck Supper.

In order for the trial to run smoothly, we will need the help of all handlers. Please volunteer for one of the following work areas: set-up of fencing, take down of fencing, sheep pen, setting out sheep, exhausting sheep, announcing to the public, scribing for the judge and secretarial duties.

2018 Novice Whistle Challenge

The MA Sheep and Woolcraft Sheep Dog trial will participate in the 2018 Novice Whistle Challenge, designed for the Novice Handlers participating in the 2018 Trial Season. The intent is to encourage the novice handlers to introduce the use of the whistle during their training and demonstrate the appropriate use while running in a trial. This is intended to be fun, encourage some new learning either independently or with an instructor and provide a bit of a challenge for all.

Handler Criteria

There will be a challenge in each of the novice classes for those handlers who have not run in open or in any level above the current class in which they are running. The challenge will be introducing the appropriate use of the whistle during the run at a trial.

- For the NN handler who has never run in any upper level class the handler who uses the stop whistle appropriately during their run will be recognized.
- For the PN handler who has never run in any upper level class the handler who uses the stop whistle and a flank whistle appropriately will be recognized.

- For the Ranch handler who has never run in any upper level class including nursery who uses the stop, and 2 flank whistles appropriately during their run will be recognized.

Rules and Regulations

1. There will be a limit of 2 dogs per handler, regardless of ownership, per class. Third dogs will be accepted on a space available basis. Please send a separate check for any third dogs and for USBCHA Nursery dogs. Dogs may **not** run in ranch and open.
2. Entry fees: US Funds. Open class - \$50/dog; Novice and ProNovice - \$33/dog; Ranch - \$35/dog. USBCHA Nursery \$33/dog. Ranch and USBCA Nursery \$45 – please send separate check for the Nursery portion. Note dogs can run in Pronovice and Nursery, but if they are running at the ranch level and nursery, you only get one run. Entries open **April 5, 2018** and close (must be postmarked) on **April 30, 2018**. Entries mailed earlier will be treated as being received on the opening date. Entries will be accepted until the closing date, or until classes fill. Running orders will be drawn by May 10th. **Receipt of completed entry forms and fee constitute entry. No emailed entries will be accepted. Entry fee from cancelled entries will be returned provided notification of cancellation is made before Wednesday, May 10th.**
3. Ribbons will be awarded in all classes (except USBCHA Nursery). The top 10 winners in the Open class will receive prize money.
4. Any damage done to the sheep by the dog, on or off the course, will be the responsibility of the handler.
5. Unsportsmanlike conduct will not be tolerated.
6. Dogs will be under control at all times. Handlers are asked NOT to walk their dogs in the vendor and sheep barn area. Handlers are asked to clean up after their dogs.
7. No puppies will be displayed for sale.
