Checks will be cashed on April 5 – no refunds after Apr. 5 unless a veterinary or medical issue prevents you from coming to the trial.

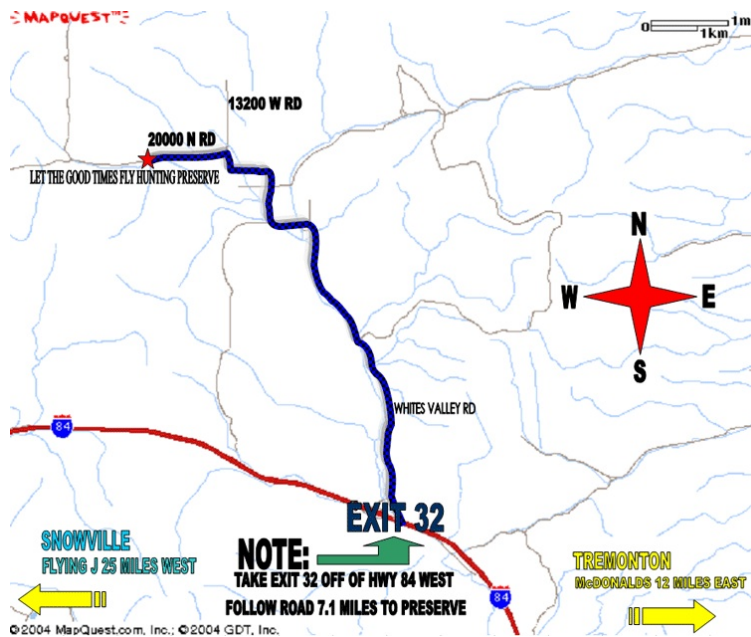
Probable class order but may change depending on entries:
