Directions: From Jefferson City: Take Highway 54 towards Lake of the Ozarks about 7 miles. Turn right onto West Brazito Road. In about 5 miles, turn right onto Blackburn Road, which is across from a sign that says, "Lake Carmel." Go ¼ mile. Turn right on Clibourn Road. Go 1 mile. At the sharp turn in road, go straight into the driveway. | **From the south:** Take Highway 54 towards Jefferson City turn left on West Brazito Road then follow directions above. | **From the west:** Take Highway C to Russellville. Go through Russellville, and turn right on Highway AA. Turn left on Scrivner Road. Turn left on Dawson Road. Go about 1.5 miles and turn left into driveway.
