### Directions to Cedar Stone Farm, N3909 Airport Rd., Cambridge, WI 53523

#### From the North:

I-90/94/39 or 51/39 South to Madison, Wisconsin. Take Exit 142B/ Hwy. 12/18 East through Cambridge to Airport Road (about 1 mile east of Cambridge). Turn right onto Airport Road and follow signs to trial field.

**OR** Hwy. 26 South to Fort Atkinson, Wisconsin. Take Hwy. 12 Exit. Travel West on Hwy. 12 about 9 miles. Turn left onto Airport Road and follow signs to trial field.

#### From the South:

I-90/39 North to Janesville, Wisconsin. Take exit 171b to Milton / Fort Atkinson and follow Hwy. 26 North to Fort Atkinson. Take Fort Atkinson Exit 142B/ Hwy. 12. Turn left at ramp stop sign and take Hwy 12 West toward Cambridge for about 9 miles. Turn left onto Airport Road and follow signs to trial field.

**OR** I-90/39 past Janesville, Wisconsin to Exit 160, Hwy. 73. Follow Hwy 73 North to Hwy. 12/18. Turn right (East) on Hwy. 12 to Airport Rd (about 1 mile east of Cambridge). Turn right onto Airport Rd. and follow signs to trial field.

#### From the East:

I-94 West to Johnson Creek, Wisconsin. Take Exit 267/Hwy. 26. Travel South on Hwy. 26 to Fort Atkinson and Hwy. 12 Exit. Travel West on Hwy. 12 about 9 miles. Turn left onto Airport Road and follow signs to trial field.

#### From the West:

Take Hwy. 12 East from Madison, Wisconsin through Cambridge to Airport Road (about 1 mile east of Cambridge). Turn right onto Airport Road and follow signs to trial field.

**CAMPING** is available adjacent to the trial field. Follow signs. No hook ups available.
