Location and parking: 1446 Berletts Road, St. Agatha (or Wilmot), ON. Please enter through gate to right of driveway and follow marked track to parking area (see map below). Please park only in designated parking area or you will be asked to move. If you need alternative parking please contact Victoria to arrange.

Running order: see below. Running order is subject to change. Changes will be posted on the scoreboard at the trial.

Start Time: 8:00 AM followed immediately by first dog at the post

Order of Classes:

Friday: Open I

Saturday: Ranch, Novice-Novice I, Pro-Novice, Novice Novice II

Sunday: Open II, Modified Double lift

Open Double Lift Qualification: 7 spots comprised of top three each trial plus top combined score from both trials. Max 2 dogs in DL per handler.

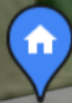
