PRE-ENTRIES ONLY -- Entries must be RECEIVED by May 2, 2026

Location: 19350 K Road, Mayetta, KS 66509

Dual Sanctioned: USBCHA (2026 Points) & MSSA (2027 Points)

CLASSES & SANCTIONING:

- Open — Sanctioned with USBCHA & MSSA
- Nursery — Sanctioned with USBCHA & MSSA
- Intermediate — Sanctioned with MSSA
- Novice — Sanctioned with MSSA

ENTRY FEES:

- Open: \$75 per run
- Nursery: \$75 per run
- Intermediate: \$70 per run
- Novice: \$70 per run

SCHEDULE:

- Open Handler Meeting @ 7:45 a.m. Trial starts promptly @ 8:00 a.m.
- Run order: Open, nursery, intermediate, novice (host reserves the right to make changes based upon weather or livestock conditions)

PAYBACK:

- Proceeds of entry fees less stock fees and sanctioning will be applied to payback.

LIMITS & STOCK:

- Entries limited to 60 runs per day — NO EXCEPTIONS.
- Limit 2 dogs per handler per class
- Cattle: 60-65 head Black Angus ~400 lb calves.

PRE - ENTRIES *only*. No entries red of event. Entries must be received by May 2, 2026

The only exception for day of entry will be in the event of substitution for a no-show pre-entry or an injured dog.

NOTICES

- In the event of rain, the event will be cancelled and entry fees returned, or the event may be postponed.
- Ashcrafts are not (nor are any of the help putting on the trial) responsible for accidents or injuries to visitors, visitors' property, or their animals.
- Very limited dry camping may be available depending upon weather conditions.
- Sloppy joes or other sandwich will be available for lunch.
- All exhibitors **MUST** pick up after their dogs and themselves. Bring weather appropriate protection and gear; bring lawn chairs.
- Handler responsibility for injured livestock: If a dog or handler causes injury or death to livestock, the handler may be required to pay replacement cost or veterinary expenses *as determined by the trial hosts*.
- Please show respect for the judges, course director, and timekeepers and stock handlers, livestock, your dogs and others' dogs. The hosts reserve the right to refuse participation. We are here to exhibit the Nine Fruits of the Spirit and to show good, positive support for others.
