Directions from Hwy 97: Go north on Chase Falkland Road (center of Falkland) for approx. 13 KM Go past Pillar Lake Resort. Take first left Moser Road, 2.5 km to stop sign at T intersection. Go left onto Paxton Valley Road. Watch for parking signs.

Directions from Hwy 1 at Chase. West of Chase take Chase Creek-Shuswap Road(turns into Chase Falkland). 27 Km to Paxton Valley Road, turn right. Trial Field after 1st cattle guard crossing. There is about 15 km of gravel on this route.

My signature confirms that I assume full and sole responsibility for, and liability associated with, and will hold the Trial Parties harmless in relation to, the conduct of myself and my Related Parties while attending the Trials and any losses resulting therefrom.
