Two USBCHA- and NEBCA-sanctioned Open trials will be held on 10/30/26 and 10/31/26. Entries may be limited due to available daylight. On 11/1/26, a 15-team Double Lift Championship will be held. The finalists will include the five highest scores from Open 1, the five highest scores from Open 2, and the five highest combined scores. To be eligible for the Double Lift Championship, dogs must have NEBCA High Points for the trial season that ended on July 31, 2026, and handlers must be NEBCA members in good standing. The two Open trials are open to handlers who are not NEBCA members and to dogs without High Points.

Entries open on 9/1/26 and close on 9/15/26. All entries received during the entry period will be treated equally; early entry is accepted but does not guarantee a spot. Checks will be cashed, and no refunds will be issued after 9/15/26. If a draw is needed, information will be posted shortly after entries close. The running order will be drawn and posted the week before the trial.

Entry fees: \$80 per Open trial. Please send a separate check for any third Open dog. Checks for third dogs will not be deposited if third dogs are not allowed.

Payment information: Checks only and they should be made payable to NEBCA.

Camping: Camping is available. No hookups are provided.
