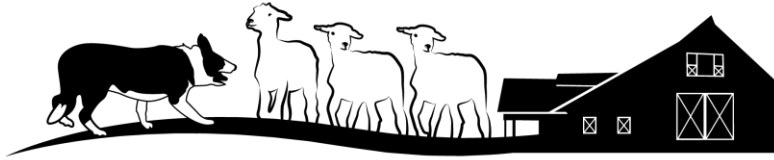


# Catbird Stockdogs SDT
