Housekeeping and COVID – 19 Measures

Toilets:

- If you are bringing your camper with toilet facilities, please use it. Four toilets will be provided, when you exit them, prop the door open with the stick provided, so it ventilates between uses. Once again, if you have your own, please use it to ensure there will be enough for others who do not.
- There will also be a separate hand wash station

General use trial areas:

- Sanitizer will be provided so that each handler can sanitize their hands entering and exiting the field

Handlers are expected to do the following:

- Stay home if you have a cough, fever or any other symptoms of illness or believe you may have been exposed to Covid-19
- Participants must not violate any travel or gathering measures still in effect where they live
- Bring your own hand sanitizer for off field use
- Practice social distancing consistent with current guidelines. Wear a mask when in close proximity to others, keep it with you
- Remember to distance when approaching the judge/scribe, or wear a mask until you are at the post
- Bring your own food and drink
- Bring your own shade, there will not be a handler's tent
- Do not sit in another person's chair or tent unless they are part of your "bubble", and of course invited to do so 😊
