Camping will be at Ranch Headquarters and is limited.

Please write on this entry if you are planning to park an RV.

Field is some distance from camping area. Day parking will be within 300 yards of Field.

Sheep: McCormack Ranch South African Merino yearling ewes. It is a commercial flock, not a farm flock.
Sheep may be re-run.

Course: Hill field. Outrun between 300 and 500 yards. Exhaust your own sheep.

Any excessively rash behavior, abuse of dog or sheep, will result in disqualification at judge's discretion. Setout will be done by Virginia Dains. Volunteer pen help will be assigned.

Payout: Payout will be 100% of proceeds *after all expenses have been paid*. There will be no payout in Nursery and Pro-Novice.

Schedule: Open (\$80/run) – Friday and Saturday
Nursery (\$60/run) – Sunday AM and PM
Pro-Novice (\$60) – Sunday between the two Nursery trials

Please write separate check for third dogs. Entries open February 14-February 26, 2022 and all entries received during this time will be treated equally.

Covid-19 Guidelines: Handlers are strongly encouraged to follow recommended Covid-19 guidelines. Please bring your own hand sanitizer and/or soap and water. Portable toilet doors will be propped open when not in use. If you are sick, please do not attend, and your entry will be refunded if you are unable to attend due to Covid-19.

Please treat the Ranch and Sheep with care and respect. Please take all trash with you (there will be no trash cans). There are blind curves on the Ranch roads. Please drive with extreme caution.
