

## Tepee Rock Arena Trial Series

### Joliet, Montana

Submit a **separate** entry for each trial. Checks payable to Tammy Yost-Wildin, mail payment and entry to : Tammy Yost-Wildin P.O. Box 42 Joliet, MT 59041. Entries will be limited and accepted according to postmark. Entries submitted without payment will be rejected. Entries withdrawn by the closing date will be refunded. No refunds after closing date. All trials will run on Rambouillet yearlings/Crossbred range Yearlings. \$300 sheep replacement charge in the event of serious injury or death of a sheep.

On-site parking/camping available, no hookups. Please clean up after your dogs! Walking areas will be designated and strictly enforced. 212 Cafe and Jane Dough's are available in Joliet for dining, Laurel and Red Lodge are each 24 miles away with other options. We may have a food truck onsite and will let everyone know closer to the trials.

Trial will be held at the Tepee Rock Arena, just South of Joliet, Montana. Turn onto Main Street in Joliet(Conoco gas station on the corner), go straight over the bridge stay right, then IMMEDIATELY turn left up the hill! Stay on that road for two miles. Arena is on the left. Entrance will be marked.

Two dogs per handler per class. If space allows, we will allow third dogs. Note on entry if you have a third dog and you may pay at the trial if space allows. ONLY remit payment for your first two dogs!

Class Definitions:

**Open** - Open level handler

**Nursery** - Dog has not turned three years old BEFORE July 1, 2023 (USBCHA rule), Open or Pro Novice handler. Novice handlers showing in Nursery are no longer qualified for Novice class!

**Pro Novice** - Handler has never shown in Open showing a dog of any level or Open handler showing a dog that has never shown in Open.

**Novice** - Handler has never shown above Novice, Dog of any level

We WILL need volunteers for sheep set out, so please note on your entry if you are able to help and during which classes! Your help is sincerely appreciated! We are trying to make these trials fun and an opportunity for new handlers to get their feet wet while providing a great opportunity for experienced handlers to show as well.

Series awards will be given for Open, Nursery, Pro Novice and Novice! Judges TBA for each trial.
