## **Release from Liability and Waiver of Claims Related to Attendance or Participation at Sheepdog Clinics and Trials**

This Release from Liability and Waiver of Claims is given by the undersigned (hereafter, "the Undersigned"), whose name and signature appears below, in favor of Tom Wilson Sheepdog Trials & Clinics LLC, a Virginia limited liability company, Thomas Wilson, an individual, and Florence R. Wilson, an individual.

1. Tom Wilson Sheepdog Trials & Clinics LLC (hereafter, the Company) conducts sheepdog clinics and trials, both in Central Virginia and elsewhere, for the benefit of the community of sheepdog owners and sheepdog enthusiasts.
2. Thomas Wilson, of Albemarle County, Virginia, is the sole owner and manager of the Company and conducts the activities of the Company.
3. Florence R. Wilson is the wife of Thomas Wilson and the owner of Edgeworth Farm, located in Gordonsville, Albemarle County, Virginia, the land on which many of the sheepdog trials and clinics are held and conducted. She leases to the Company the right to conduct such trials and clinics at Edgeworth Farm for the enjoyment of sheepdog owners and sheepdog enthusiasts.
4. Attendance or participation in a sheepdog trial and clinic is an inherently dangerous activity. There are numerous obvious and non-obvious inherent risks always present in such activity despite all safety precautions. These risks include (i) a dog or a sheep running into a person or another animal at a high rate of speed, (ii) freak weather occurrences such as thunder, lightning, or rain, (iii) insects, reptiles or other animals that might bite or sting a person or animal, (iv) walking or riding on irregular footing on outdoor groomed or wild land, and (v) the reality that training activities are often conducted at sites that are remote from medical care.
5. The Undersigned understand that these risks can lead to personal injury, illness, permanent disability, and death to the Undersigned and to the Undersigned's dogs, sheep, and other animals. The Undersigned further understands that the Company requires as a condition to the Undersigned's attendance at or participation in its sheepdog clinics and trials the execution and delivery of this Release from Liability and Waiver of Claims.

Now therefore, the Undersigned on behalf of himself or herself, his or her descendants, ancestors, dependents, heirs, executors, administrators, assigns, and successors, and each of them, hereby covenants not to sue and fully releases, acquits, and discharges Tom Wilson Sheepdog Trials & Clinics LLC, Thomas Wilson, Florence R. Wilson, and their respective agents, successors and assigns, from any and all claims for loss, damage, or injury which the Undersigned may suffer arising out of or connected with his or her attendance or participation in a sheepdog trial or sheepdog clinic, whether at Edgeworth Farm, in Gordonsville, Virginia, or elsewhere, even if caused by the ordinary negligence of any of the released parties, whether active, passive, or otherwise.

Furthermore, the Undersigned understands that this is a legal document which is binding upon the Undersigned, the Undersigned's personal representatives, heirs, next of kin, executors, administrators, and assigns.

The Undersigned represents that he or she is 18 years of age or older and has full capacity to execute and deliver this Release from Liability and Waiver of Claims. If the Undersigned has not reached age 18, the Undersigned's parent or other legal guardian has read, understood and executed this document on behalf of the Undersigned.
