**\*Approximately THIRTY RUNS PER Session; \$45.00 per entry:**

**Saturday morning** – Ranch, Pro-Novice and Novice-Novice.

**Saturday afternoon** – Open and Nursery have priority, but unsanctioned classes will be accepted as space allows

**Sunday morning** – Open and Nursery have priority, but unsanctioned classes will be accepted as space allows

Open and Nursery entries only (for Saturday evening and Sunday morning, accepted through June 30, entries accepted for all classes as of July 1, if space allows.

**!!! New!!! “First day” of entries** (electronic or postmark) opens **June 24 - June 26**. All electronic receipts and postmarks of this date range will be treated as **first day entries**.

**Please note** - **ALL EARLY entries will be processed as received on the second day** whether postmarked or received electronically **before** the opening dates. **(In other words, PLEASE NO early entries.) Entries close July 10, 2024 or when full.**

Dates of receipt are based on the last date received, e.g., if the entry is emailed one day and the check is mailed the next day, the date will be based on the based on the postmark.

**Day of trial entries** may be accepted, if space allows. Any entries received without payment will be declined until accompanied with payment and processed in order that payment is received.
