**Location:** 1446 Berletts Road, Saint Agatha (or Wilmot), ON, N0B 2L0.

Enter through gate at the end of the driveway to the right, follow the track to handler parking in the training field (see map below). **Warning: gate into trial field may have electric wire running across the bottom. Use plastic handle to open and close wire as needed to enter parking area.**

**Start Time both days:** 7:00 AM handlers meeting followed immediately by first handler at the post.

**Order of Classes:**

Mornings in the training pasture - Ranch/Nursery, Pro-novice, Novice-novice

Afternoons in the big field: Open
