Directions to Trial Site:

Coming from the South take Interstate 29 to the Glenwood exit. Head east to the Silver City turn off. Go north (left) stay on the blacktop north and go thru Silver City to the first black top road-Cary Ave Go East (right). Stay on the black top road (Cary Ave) to 340th- go right and we are the second place on the right side of the road.

Coming from the North take Interstate 29 south toward KC get off at the HWY 92 exit and head east on 92 until you come to the turn off for Silver City (right before you get to Treynor IA) go right stay on it for approximately 7 miles to Cary Ave. Go left on Cary Ave and stay on the blacktop to 340th street. Go right on 340th and we are the second place on the right side of the road.
