CLASSES: 2 Open and 2 Nursery (Pro Novice possible if other classes don't fill)

ENTRY FEES: Open \$75/run, Nursery \$55/run, Pro Novice \$65/run. Due to daylight and sheep numbers, open is limited to 40 entries per day. Unlimited number of nursery dogs. Pro Novice will be offered if other classes do not fill. It will be posted on FB District 1 page if PN is available. Field will be flood irrigated cattle pasture with uneven surfaces.

Any dog causing a substantial wreck or serious injury to stock is subject to removal from the next trial without a refund at the discretion of judges and/or trial host.
